A uniform system for the permitting of overweight and oversized loads on participating county, township, and city roadways.

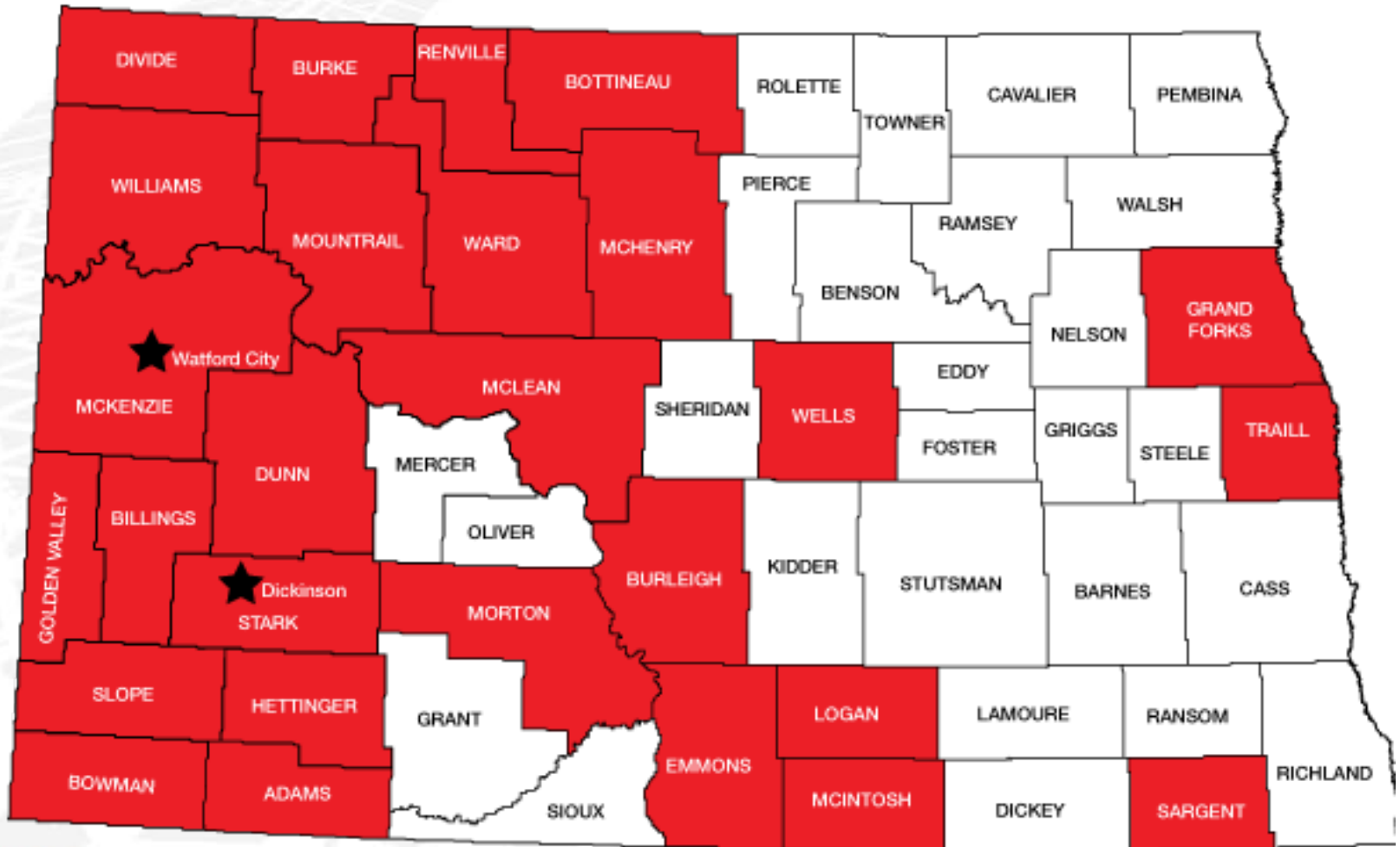

Permit System History

- Started in 1984 by ND Association of Oil and Gas Producing Counties (currently Western Dakota Energy Association).
 - For traffic tracking on oilfield roads
- Started with Self-Issue Paper permits
 - ‘On your honor system’
 - System was not uniform
 - 1990’s – group agreed upon one uniform fee schedule for all counties
- 2010 - the online ePermit Management System was built
- ePermits AND self-issue paper permits were issued until 2015 when paper permits were discontinued
- In 2017 the ‘Uniform Truck Permit System’ was rebranded to LoadPass Permits
- WDEA voted to expand to any or all states in North Dakota



Types of Permits

- Trip Permit – Graduated Fee Schedule
 - Categories
 - Trucks & Trailers
 - Workover Rigs & Cranes
 - Earth Moving Equipment (roaded)
- Restricted Road Permit – ton/mile fee
- Xcess Permit – ton/mile fee
 - Over 150,000 lb. GVW
- Harvest Permit – 10% over
- Wintertime Permit – 10% over
- Annual Over-Width Permit
- Frost Law Permit

Why LoadPass Permits?

- Provides uniformity across county lines for both local governments and industry
- Single point for industry to obtain permits for multiple local governments
- Manage traffic using color-coded user-friendly Dashboard



LoadPass Permits – Membership Benefits

- Retain control of local roads
- Increase revenues for road maintenance
- Reduce office and telephone traffic
- Receive funds via ACH into bank account each month
- Prepare for future projects
 - Pipelines
 - Wind Farms
 - Energy
 - Construction
 - Agriculture



Member Responsibilities

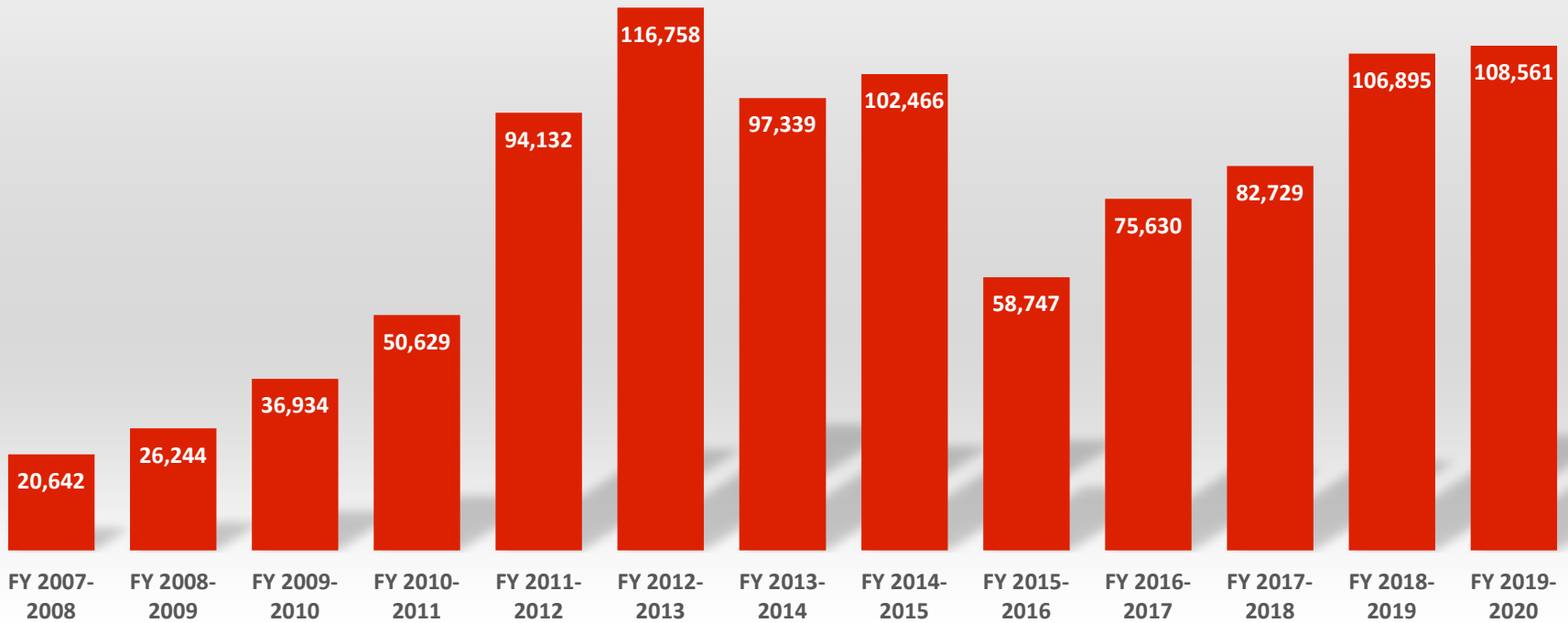
- Designated Member Contact Person(s)

- Submit Road Network Changes
- Participate in semi-annual LoadPass Advisory Committee meetings to oversee LoadPass system

Membership Fees

- Initial Fee - \$1,500
 - Covers Initial Setup and Training
- Subsequent Years – Based on number of permits sold the prior year

Permits Sold:	0 - 500	\$ 500 / year
	501-1,500	\$ 750
	1,501-3,000	\$ 1,250
	3,001-5,000	\$ 1,500
	5,001- over	\$ 2,000

LoadPass Communication System

- Post load restrictions, road closings, restrictions lifted, construction projects, etc.
- 13,000+ registered users who receive notifications
 - Texts
 - Emails

House Bill 1320

- HB 1320 (2016)
 - 5-day Signage Waiver
 - No signage required for road restrictions - up to 5 days
 - if notification is sent out on a notification system
 - Township Participation
 - If a county is a member of a uniform permit system, and an organized township within that county wants to issue travel permits, they must be part of that same uniform system

Routable Road Network

- Routable Road Network
 - Released August 20, 2018
 - 2-1/2 Year Project
 - 85% of permits are currently being requested using the GIS routing option
 - Manual routing will eventually be discontinued
 - Training is available
